WWMG Cardiology is recruiting for an Advanced Practice Clinician (APC) – a Nurse Practitioner or Physician Assistant. Our Department of Cardiology is staffed by 7 cardiologists in the sub-specialties of general cardiology, heart failure, interventional cardiology, structural cardiology and electrophysiology. We also have the WWMG Cardiac Imaging Center co-located with our primary location in Silver Lake, Everett where treadmill, echo, nuclear and vascular testing are performed.

Our APC team provides both outpatient and hospital-based cardiac care in conjunction with our Cardiologists. Outpatient clinic is centered at our Silver Lake office in Everett. Inpatient work is done at Providence Regional Medical Center Everett. There is no evening or night call. Weekend responsibilities are shared in a larger group format and are approximately 1 in 6-7.
